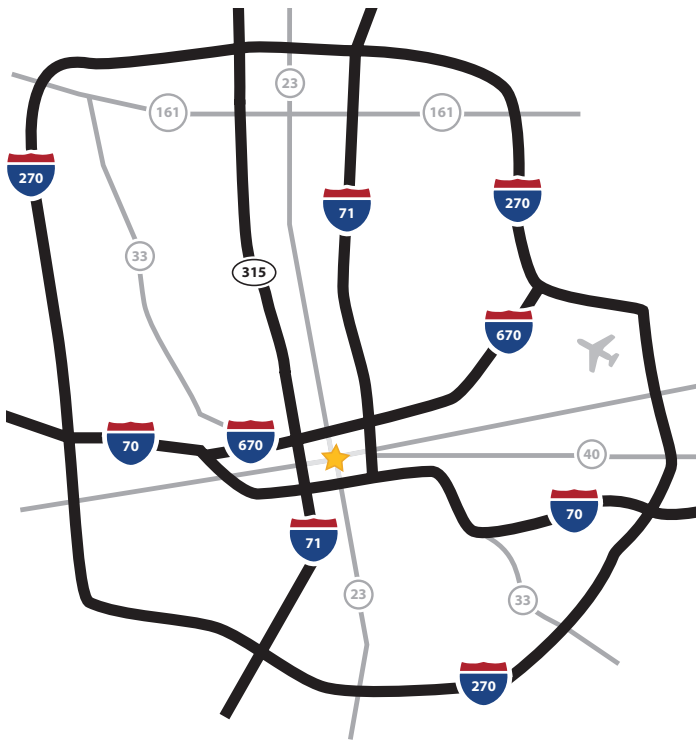


DRIVING & PARKING DIRECTIONS

140 E. Town Street, Columbus, OH 43215

FROM THE EAST

I-70 west to exit 101B toward downtown Columbus
Exit onto East Mound Street and follow to Fourth Street, turn right
Follow Fourth Street to Town Street
OP&F is on the corner of Town and Fourth Streets

FROM THE WEST

I-70 east to exit 100B (this exit ramp will turn into Livingston Avenue)
Continue straight through the first light and turn left onto Fourth Street
Merge right in order to stay on Fourth Street and continue to Town Street
OP&F is on the corner of Town and Fourth Streets

FROM THE SOUTH

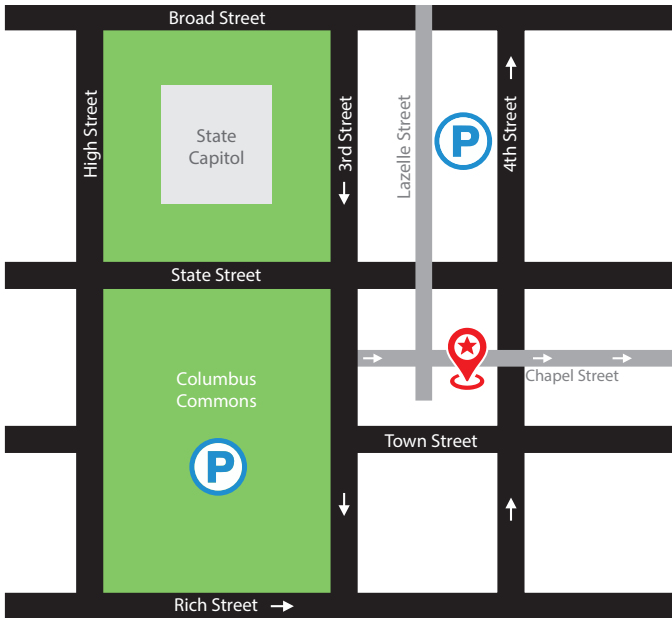
I-71 north to I-70 east to exit 100B
100B exit ramp will turn into Livingston Avenue
Continue straight through the first light and turn left onto Fourth Street
Merge right in order to stay on Fourth Street and continue to Town Street
OP&F is on the corner of Town and Fourth Streets

FROM THE NORTH

I-71 south to exit 109B E. Spring Street
Use the right lane to take exit 109B toward Downtown
Turn right on E. Spring Street
Turn left on N. Third Street
Follow Third Street to Town Street, turn left
OP&F is on the corner of Town and Fourth Streets

FROM THE NORTHWEST

From I-270 on Columbus' north side, take Ohio Route 315 south
Follow Route 315 to I-670 east
Follow I-670 to exit 4A to North Third Street.
Continue on Third Street to Town Street, turn left
OP&F is on the corner of Town and Fourth Streets



HAVE A SCHEDULED APPOINTMENT?

OP&F members who have a scheduled retirement interview may access the OP&F parking garage from 8 a.m. to 4:30 p.m. All other visitors should park at the meters in front of the OP&F building or at one of several nearby lots.

The entrance to the OP&F parking garage is at the rear of the building using either Lazelle Street or Chapel Street.

OP&F PARKING GARAGE INSTRUCTIONS

Access to the garage is for scheduled appointments only. If you do not have an appointment, use the metered parking in front of the building. Garage hours are 8 a.m. to 4:30 p.m.

The garage is located at OP&F headquarters on floors two through five at 140 E. Town Street in downtown Columbus.

Access to the garage is from the rear of the building using either Lazelle Street (going south from State Street) or Chapel Street (going east from Third Street).

Please remember that throughout the garage and the ramp to and from the garage is two-way traffic. Please keep to the right at all times.

Proceed up the ramp to the parking garage gate. Press the call button for building security.

Provide security with your name and that you are visiting for a scheduled retirement appointment with OP&F. Please inform security if you need assistance getting from your car to the lobby.

There is reserved parking for guests located on Level 5. Disabled parking spaces are also available on Level 5.

Once you are parked, take the garage elevators down to the lobby (L) and sign in with the receptionist in the OP&F Reception Center.

When exiting the garage, proceed to the exit gate and press the call button for security. Let security know that you are leaving your retirement meeting and they will open the gates for you.

Proceed down the ramp to Chapel Street and turn right (it is a one-way street).

STREET PARKING PAYMENT METHODS

Parking in front or on the sides of OP&F building between the hours of 8 a.m. - 10 p. m. will require payment.

PAY AT KIOSK

There are kiosks located on Third Street and Fourth Street, near Town St. Please have your license plate number on hand and follow the screen instructions to make payment.
