The plan defines specific areas to be reviewed during 2023. The plan is a dynamic document that may change based on new information or emerging risk coming to my attention (agile approach). Changes in audit resources, operations or requests from management may require modifications to the plan. The Committee will be informed of significant modifications to the Plan. The audit plan is designed to provide coverage for key business processes, given the existing internal audit staff member of one. I believe the areas identified for review will result in the best return on the audit resource investment.
