#### **AGENDA ITEM 3:**

Ms. Foley, reviewed the Federal Legislative Report. OP&F have pursued a great deal of activity on the federal level in in the first quarter. Our federal working group with Sherrod Brown for Medicare at 55 for public safety is progressing quickly now. The bill is expected to be introduced in late March. We have asked for Republican sponsorship from Senator Corey Gardner, R-Colorado who is up for re-election in what is now a blue state. We are cautiously optimistic, as he did not flatly refuse as other Republicans have. We also met with AON and UHC to secure their federal lobbying efforts for Medicare at for public safety. Both agreed.

Mr. Patton attended the NCPERS legislative conference and lobbied on the hill. He distributed information regarding OP&F along with Medicare at 55.

Ms. Foley outlined some of the developments on other federal issues that impact public funds and which we are monitoring with our many public fund partners in the upcoming session:
